

1. The presentation has covered only four modules. Two of our students are interested in logistics module. Can we offer this module to students?

Ans :- The four modules offered are

- o Finance/Accounting
- o Human resources
- o Advanced Business Application Programming (ABAP)
- o Order fulfillment (Sales and Distribution)

Each Module is heavy and needs 200 hours and there will be practical problems in doing all four. Students have to opt for one module only. Even cursory learning of other modules will be difficult.

2. Can the payment of the course fee be done in installments?

No installments are allowed.

3. When will the course start?

We expect the course to be fully operational latest by 25th October 2013.

4. When will the certification exam be conducted?

There are two types of certification.

Participation Certification :-

Eligibility criteria this certification is completion of 200 hours training and clearance of exam conducted by SAP& Raisoni. Participation certificate will be given jointly by SAP& Raisoni on successful exam clearance.

Global certification

Global certification is given by SAP Germany on successful clearing of online exams conducted by them. Students who have successfully cleared participation certification program have to appear for this Global certification within one year from the date of Participation certification.

5. Is it Mandatory to obtain Global certification?

It is not mandatory from RGI perspective. Students who want to opt for Global career can do this course as per their requirement.

6. What is type of exams conducted?

For Participation certification it will be online objective type exam of 2 hours. Students will be given two chances (subject to vary at later date). If students do not clear the exam in two attempts they have to undergo the training again in case they require the certificate by paying prevailing course fee at that time..

For Global certification Exam is online objective type with 3 hours duration. Every attempt has a condition fresh fee payment. Exam has to be done within one year of clearing participation certification. Certificate is issued by SAP Germany which is recognized globally.

7. How much will be the exam fee?

No additional exam fee for participation certification.

Global certification exam cost 30 to 35 K as on date (September 2013)

8. Where do we need to register for global certification?

Online registration SAP website

9. In there any training provided for clearing the global certification exam.

No special training is required. However our library will be equipped with standard books of objective type . Students can buy this from market. We may provide practice test for students

10. Time limit of daily sessions

There is no time limit from RGI perspective. Since this LMS module students are liberty to fix their own timing. However it is strongly recommended for two hour session every day to complete the course in prescribed five months' time.

11. Who will provide placement assistance and is there any guarantee of placement (SAP/Seed/Raisoni)?

Placement is always on companies' requirement and one's capabilities and how they fare in campus placements. Hence there is limitation from our part for guarantee of placements. However RGI on its part will bring companies who are partners of SAP. Best of efforts will be done to bring companies to Campus for placement. SEED/SAP as partner will be supplementing our efforts of bringing companies.
